A Look Back to NSCPs First National Conference

NSCP's First Annual Membership Meeting

The First Annual Meeting of NSCP Members was held on July 28, 1988 at the Warwick Hotel in New York City. Those unable to attend missed the opportunity of meeting over 120 of their colleagues (more than a quarter of NSCP's membership as of June 30, 1988) from all over the country.

The meeting was an educational, as well as social, event – attendees departed with practical answers to "nuts & bolts" problems. In coming issues, NSCP *CURRENTS* will feature articles on the meeting (contributed by NSCP's Executive Director and some general session speakers); members who weren't there on July 28th may thereby still benefit from some of the valuable tips "dropped" during the general session presentations.

Following NSCP President Lee Faulkner's welcoming remarks, Rick Ketchum (Director of the SEC's Division of Market Regulation) spoke to the assembly on "Compliance After Boesky and The Crash – An SEC Perspective."

Mr. Ketchum chose his presentation title because Boesky and "the crash" combined to trigger a new awareness of the compliance officer's role. "The impact of the crash changed the level of focus on the importance of how the [compliance officer's] job is done." Mr. Ketchum said the compliance officer's role should have a direct impact on how firms conduct business, as well as on what type of legislation we'll be seeing in the near future, the bottom line being "insuring investor confidence at a time when investors are *looking* for a reason to have confidence in the market place."

Mr. Ketchum continued by identifying issues the SEC finds relevant to the compliance function. One area of note was margin account disclosure. The extra-ordinary rate of complaints that came out of the crash reflect, among other things, the general customer misunderstanding of firms' abilities to liquidate margin accounts at their calling. "The manner and degree of specificity of present disclosure of [this] ability warrants a great deal more focus." For the compliance officer, this means taking a careful look at the level of communication with their firm's registered representatives as to customer account administration.

Another area of major significance stressed by Mr. Ketchum is ongoing training of registered salespeople. "It's not the successful completion of (qualification) examinations that will assure firms that reps know what they're doing – it's only through your communication (continual training) that that can happen. It seems to me, national organizations such as the one you're forming here are particularly in a good place to deal with the problems of small and medium firms in training account executives Focus on ways to maintain ongoing training. The problem won't go away."

Identifying another related issue the SEC thinks very important, Mr. Ketchum went on to say that " ... we have to find a way to identify problem reps and to insure that they don't continue to walk on in the business." Brokerage firms' Form U-5 disclosure concerns (i.e., the concern of possible exposure to employee litigation were acknowledged. "The ability to communicate candidly about problems is another issue I recommend your organization focus on." He indicated a willingness to discuss "ways we can have more specific rules - perhaps even legislation that would provide limited immunity in the area." Additionally, Mr. Ketchum warned that "in the future, we'll expect special compliance capabilities if you're going to bring on reps that have had problems in the past."

The impact of the Boesky incident increases the SEC's focus on the importance of "Chinese Walls." The staff will be taking a closer look at accountability and auditability in connection with firms' Chinese Wall procedures. "With proper design and implementation, there should be written audit trails for us to be able to evaluate your procedures."

Mr. Ketchum closed his speech by encouraging NSCP members "to transform and to use NSCP as an input mechanism to give you an opportunity to meet the regulators, to give us an opportunity to learn (in a more informal context) about your businesses, and to give you an opportunity to tell us what you think about what's going on."

Next on the podium was Mr. Saul S. Cohen, Esq., of Rosenman and Colin. Mr. Cohen, a keynote speaker, presented a speech entitled, "The Compliance Officer's Liability," which offered ten safety tips for compliance directors.

Having stated the compliance officer's position as defined by the SIA and Section 15 (b) (4) (E) of The Act, Mr. Cohen described ten actions that, depending upon such factors as a firm's size and wealth, the compliance officer should consider in order to protect himself and his firm.

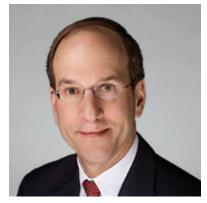

Do's and Don'ts When Speaking with Regulators

The National Society of Compliance Professionals (NSCP) is taking a significant step toward fostering collaboration and understanding between the industry and regulators. We have extended a warm invitation to regulators this year to attend portions of our upcoming National Conference.

At NSCP, we firmly believe that to create effective regulations, regulators must have a comprehensive understanding of the landscape they oversee. By inviting regulators to our conference, we aim to provide them with a unique opportunity to gain insights directly from compliance professionals, industry leaders, and subject matter experts who navigate the intricacies of regulatory compliance daily.

This invitation is not just about regulators gaining knowledge; it is equally about creating an environment where our valued NSCP conference attendees feel comfortable and supported. We understand that effective regulation requires open lines of communication and a shared understanding of the challenges faced by both regulators and compliance professionals. By bringing everyone together, we can bridge the gap and foster constructive dialogue that leads to better outcomes for all.

Knowing that regulators' attendance at the National Conference may make compliance professionals a bit uncomfortable, we thought it would be helpful to create a list of do's and don'ts when engaging with a regulator.

What You Should Do:

Be respectful – Regulators are attending NSCP's National Conference for the same reasons you are – to obtain practical education and compliance insights on regulations from industry experts and fellow attendees, learn about industry trends, and participate in networking opportunities. Regulators should be treated with the same respect that you deserve.

Introduce yourself – A regulator may be just as nervous as you are about meeting industry attendees. Meeting others provides the chance to learn about an individual's background, gain unique perspectives, and may even lead to a valuable contact or future business partner.

Friendliness - Have a positive attitude when communicating with a regulator. Keep an open mind and ask thoughtful, open-ended questions that will create an engaging dialogue and build rapport.

Follow-Up – If you felt comfortable meeting a particular regulator, you may choose to reconnect with them at a later conference session or at a cocktail reception to get their feedback on what they have been hearing and learning at the conference.

What Not To Do:

Don't discuss compliance and personnel issues at your firm - Even if you have the best of intentions, discussing compliance and personnel issues at your firm may inadvertently put you and the regulator in an awkward position. Always remember that regulators have an affirmative duty to investigate if they are made aware of potential violations of securities regulations.

Don't ask about rule proposals and adopted rules – Regulators may not want to be put on the spot to be asked about a new rule outside of a session and they typically cannot comment on a proposed rule. Obtaining advice as to how to comply with a rule is best left to your legal counsel. Regulators may have different interpretations of rules, just as compliance professionals do.

Don't discuss regulatory examinations – If your firm recently went through or is currently going through an examination, do not discuss it with a regulator for the same reasons you should not discuss compliance and personnel issues at your firm.

Engaging with regulators should be a mutually beneficial experience, just as you would engage with other conference attendees. Please welcome them into the NSCP community so that we can all learn from one another's unique perspectives. Enjoy your conference experience!

Maximize your Conference Experience

Regulatory Definitions of Select Securities **Terms**

Over the years I found myself researching the precise definitions of certain terms time and again. I started to collect the definitions and indicate the source. Eventually, I created a table that helped me track terms that were nuanced or had different meanings in different contexts. (For example, the word "promptly" can mean that the firm must take action by noon the following day (for an introducing BD forwarding funds or securities to its clearing firm), within 3 days (for an RIA forwarding funds to its custodian), within 10 days (for certain Form U4 updates) or 30 days (for other U4 updates).) I added to the table year after year and used it regularly.

That practice evolved into this crowdsourced table by the members of the Publications Committee. This glossary identifies some terms that some of us have found to be tricky. We included links to the definitions and in many cases, offered compliance tips to help avoid traps for the unwary. Some disclaimers are required for an effort of this type, however. This glossary is not comprehensive, many of these terms have additional definitions, and not all of the definitions are equally authoritative. (For example, some of the definitions are statutory or taken from regulatory rules, while others are taken from Staff guidance or even settled enforcement cases.)

The following table has also been posted in the NSCP Resource Library in Excel format, so that members can download it and add their own terms. To make this most helpful to the NSCP membership, we welcome additional terms and compliance tips, which will be added periodically to the table. If you have any additional definitions or compliance tips, or if you notice some of the definitions have become supplanted by newer rules or guidance, please send your comments to publications@nscp.org.

Make the Exhibit Hall Work for You at the NSCP National Conference

here are many reasons to register for the NSCP National Conference: education for practical application of day to day compliance management; insight on regulator attitude; and networking with peers. But have you ever considered the value in a deliberate walk through the Conference Exhibit Hall?

Taking a few moments during your attendance to stop by the exhibit booths can help you in both your work and your professional network. Due Diligence Review

These exhibitors have been in the trenches, and may have just the right suggestion for your compliance challenges.

Develop Connections

On the lighter side, you may strike up a new professional friendship. Often, a brief conversation will uncover that you are connected with the company in some way you never would have considered. You may realize the consultant or sales representative used to work at the same firm you had, or you both greatly enjoyed a conference session to the point you can discuss takeaways.

Finally, stop by the exhibit booths to pick up a new useful gadget, wonderful trinket or innovative tool. While the giveaways aren't the only reason to stop by the booth, they can be an added bonus. See you at the Conference, and please be sure to say hello!
